At its meeting on 22 January 2025 the Council considered recommendations from its Independent Remuneration Panel in respect of the Allowances Scheme for 2025/2026. The Panel recommended changes to the Basic Allowance, including the application of indexation, changes to the allowance for Opposition leaders and removal of the allowances for Cabinet Secretary and Deputy Cabinet Member positions. The Council accepted the Panel's recommendations. The main provisions of the Scheme adopted for 2025/2026 are summarised below.

The Basic Allowance may be adjusted annually in line with any increase in the CPI published in the February prior to the relevant financial year, with this indexation to apply up to a maximum period of four years.

Carer's allowance

Subsistence Allowances (for elected members and co-optees)

In the case of absence from the usual place of residence for a continuous period which exceeds 4 hours but does not involve an overnight absence, subsistence is payable as set out below:

Tea Allowance	£3.37
Evening Meal Allowance	£10.59

Overnight Accommodation

The allowance will not be claimable as an allowance as such, rather reasonable costs of an overnight stay (including breakfast) will be met for business class accommodation (3 star or 4 star) within and outside of London. Unless there are exceptional circumstances the Council will book the accommodation direct selecting the most economic option available and utilising the established

procurement arrangements in place. Where exceptional circumstances exist, these must be approved in advance by the Director of Finance, and reasonable costs will be reimbursed subject to submission of receipts.

£15 maximum per occasion

Telephone Calls Allowance

£15 per quarter

Broadband – actual costs to be reimbursed up to a maximum of £15 per month with a contribution from each Member of £3 per month where private use is made of the facility.
